The above Renter agrees and accepts the following terms and conditions, and will hereby adhere to the following rental terms listed below.

**TIMING & FEES:**

- The balance listed above is due at the time of setup.
- No refunds, once the unit is installed and operating.
- The equipment should be empty of occupants at the requested end time. An additional hour will be charged if the Funtasia Bouncing Castles' representative must wait for the equipment to be vacated.
  - Additional hours @ \$20 per hour
  - Trip fee \$15 - \$50 applies to locations that are more than 30 miles from Funtasia Bouncing Castles' home office.

**SETUP & OPERATION:**

- Rentals that are set up on hard surfaces such as concrete or asphalt must be closely watched to prevent their moving. If the equipment moves off the provided tarp, damage or staining may occur on the bottom of the unit.
- If the Renter chooses to deflate the unit prior to the arrival of the Funtasia Bouncing Castles' representative, it must be re-inflated before it is packed up. The unit will be inspected and receive a preliminary cleaning before removal.
- The Renter will have at least 1 adult who will position himself/herself in close proximity to the entrance of the unit. This person will manage and supervise the play of children within the unit as well as assure that:
  1. All occupants remove their shoes before entering the unit.
  2. All occupants are assisted when entering and exiting the unit.
  3. Occupants are sorted by size. Only occupants of the same size should be allowed in the unit at the same time (for the protection of smaller party-goers).
  4. Occupants remove loose or sharp objects including glasses and dangling jewelry.
  5. No food, drinks, silly string, or animals are allowed in the unit at anytime.
  6. The capacity of the occupants is never to exceed:

	13' Bouncers:	
Small Children: 6-8	Medium Children: 4-6	Teens or Adults: 2-4
	15' Bouncers:	
Small Children: 10-12	Medium Children: 8-10	Teens or Adults: 6-8
  7. No occupants climb, hang or pull on the nets, sides, top, or back of the unit.
  8. No roughhousing or horseplay takes place inside, on or around the unit.

**SPECIAL PROVISIONS:**

- The unit should not be operated if wind exceeds 25mph, in rain, or in the presence of lightning.
- A representative from Funtasia Bouncing Castles will contact the Renter prior to delivering the equipment if the weather is questionable. At the time of this call, if the renter chooses not to have the equipment delivered due to weather related concerns, the full deposit will be returned. Once the unit arrives at the event, the deposit is non-refundable.
- The Renter is responsible for ensuring that the proper power source (120 volts outlet) is available and without fault. Funtasia Bouncing Castles is not responsible for any damage caused by the Renter providing an inadequate power source including, but not limited to: damage to fuse boxes, power meters, breaker units, and interior/exterior electrical outlets.

**NEGLIGENCE OR ABUSE:**

- Never leave equipment unattended.
- Only release equipment to Funtasia Bouncing Castles' representatives who furnish proof of identity.
- Funtasia Bouncing Castles will provide the requested equipment as rental items only. The stated equipment is the sole property of Funtasia Bouncing Castles and cannot be re-sold or leased without the written consent of Funtasia Bouncing Castles. Failure to return any and all property belonging to Funtasia Bouncing Castles will result in civil and criminal litigation where the said Renter will replace the equipment in question at 100% of its full market value.
- The Renter accepts full responsibility for all injuries and damages that occur as a result of this contractual agreement. And furthermore waives rights to sue for any damages or injuries that occur as a result of this contractual agreement.
- The Renter expressly assumes the responsibility of informing all persons who use and operate any equipment belonging to Funtasia Bouncing Castles that, they do so at their own risk. Neither Funtasia Bouncing Castles, nor its representatives shall be held liable for any such injuries and/or resulting losts or damages.
- The Renter agrees to be financially responsible for any damage incurred to Funtasia Bouncing Castles' equipment. Failure to comply will result in swift legal action in order to recoup all the expenses required to repair or replace the equipment to original condition. If damage is incurred while the equipment is in the possession of the Renter, damage fees vary but are estimated below:
  - \$50 -\$100 for cleaning fees
  - \$200-\$500 for repairs
  - \$3500 if the unit is not repairable

Please note that in the event of an emergency or if a problem occurs with the rented equipment, it is the responsibility of the Renter to immediately contact a Funtasia Bouncing Castles representative at 281- 821-3298 in order to expedite the proper handling of the situation at hand.
